At 6:30 p.m., Council Member Laing made a motion seconded by Council Member McIsaac to enter into an executive session pursuant to W.S. 16-4-405(a)(ii) & (a)(iii) to discuss legal action and a personnel matter. Vote was unanimous. At 6:57 p.m., Council Member Tamblyn made a motion seconded by Council Member Swett to exit the executive session. Vote was unanimous.

A regular meeting of the Cody City Council was held in the Council Chambers at City Hall in Cody, Wyoming on Tuesday, March 17, 2026. Mayor Reiter called the meeting to order at 7:00 p.m.

Council Member Settineri made a motion seconded by Council Member Swett to approve the Consent Calendar as presented, including approval of Minutes from the City Council Meeting March 3, 2026, and Work Session on March 10, 2026, approve Vouchers and payroll in the amount of \$2,436,911.54, approve a request from Yellowstone Beer Fest to close Beck Ave. from 9th to 10th Street and 10th Street from Beck to Sheridan Ave. on Saturday, July 18th for the Yellowstone Beer Fest, authorize mobile vendors to park and operate within the street closure area, authorize an open container and malt beverage permit and request organizers work with staff on additional provisions. Additionally, YBF is authorized for beer service in City Park for the (8) 2026 Concerts in the Park June - August, appoint Sarah Jacobs to the Cody Public Art Committee — Member at Large — for a term ending December 31, 2028, re-appoint Mayor Lee Ann Reiter to the Wyoming State Shooting Complex Joint Powers Board — Local Government, City of Cody — for a term ending April 30, 2029. Vote was unanimous.

Ordinance No. 2026-05 - Third and Final Reading

Council Member Settineri made a motion seconded by Council Member McIsaac to approve Ordinance 2026-05 to rezone Lots 1-12 and the N 65' 8" of Lots 15-16 of Block 14 from R-3, Medium Density Residential General Business (D-2). Vote was unanimous.

Ordinance No. 2026-06 - First Reading

Council Member Laing made a motion seconded by Council Member Settineri to approve ordinance 2026-06 to rezone Lot 1 of Holm View Addition No. 6 Subdivision from R-3 Medium-High Density Residential to R-4 High Density Residential. Vote was unanimous.

Council Member Tamblyn made a motion seconded by Council Member Swett to approve Resolution 2026-03 to approve and adopt the 2026 City of Cody Storm Drain Master Plan. Vote was unanimous.
