City Council Proceedings
June 9, 2026

A regular meeting of the Cody City Council was held in the Council Chambers at City Hall in Cody, Wyoming on Tuesday, June 9, 2026 at 5:30 PM.

Mayor Reiter called the meeting to order at 5:30 PM.

Present: Mayor Reiter, Council Members Tim McIsaac, Kelly Tamblyn, Joanna Settineri, Jeremy Laing, Don F. Shreve Jr., and Emily Swett; City Administrator Tony Tolstedt; and Administrative Services Officer Tina Gail. Absent: None.

Mayor Reiter, Tony Tolstedt and Phillip Bowman provided committee, board, and project updates. Council discussed ongoing committee activities and current project status reports.

Leslie Brumage, Finance Officer, discussed the final budget amendment for Fiscal Year 2026. Council reviewed proposed amendments and discussed year-end financial adjustments. This item will be placed on a future agenda for Council consideration.

Phillip Bowman presented the proposed Agreement for Use of City Property between the City of Cody and Park County Pedalers. Council discussed the proposed use, agreement terms, and operational considerations. This item will be placed on a future agenda for Council consideration.

Leslie Brumage reviewed proposed uncollectible write-offs and provided information regarding outstanding accounts recommended for write-off. Council discussed the recommendations and related financial impacts. This item will be placed on the June 16, 2026 agenda for Council consideration.

Tina Gail presented a request from Special Olympics for use of a City park on August 29, 2026. Council discussed the request and event logistics. Staff was given direction to place this item on the June 16, 2026 consent agenda for Council consideration.

Ordinance 2026-09 - Second Reading

An Ordinance adopting the annual budget for the City of Cody, Wyoming for the Fiscal Year ending June 30, 2027. Council Member Settineri made a motion seconded by Council Member McIsaac to approve Ordinance 2026-09 on Second Reading. Vote was unanimous.

Ordinance 2026-10 - Second Reading

An Ordinance levying taxes for the City of Cody, Wyoming for the Fiscal Year ending June 30, 2027. Council Member Swett made a motion seconded by Council Member Tamblyn to approve Ordinance 2026-10 on Second Reading. Vote was unanimous.

Tony Tolstedt presented the proposed Law Enforcement Center (LEC) Contract. Council reviewed agreement provisions, operational considerations, and financial impacts. Council Member Tamblyn made a motion seconded by Council Member Laing to approve the Law Enforcement Center Contract. Vote was unanimous.

At 6:04 p.m., Council Member McIsaac made a motion seconded by Council Member Laing to enter into executive session pursuant to W.S. 16-4-405(a)(iii) and (a)(ix). Vote was unanimous. At 6:30 p.m., Council Member Settineri made a motion seconded by Council Member Swett to exit the executive session. Vote was unanimous.

Council Member McIsaac made a motion seconded by Council Member Laing to direct legal counsel for the City to offer a proposal in litigation as discussed in executive session. Vote was unanimous.
